1. Heard learned counsel for the petitioner on interim relief.
2. The present writ petition is filed praying, direction to be issued to the respondents for allowing the petitioner for filling up the online/offline application form for one due paper 5420-Community Health Nursing-II of B.Sc. Nursing IV year.
3. The petitioner submitted that he has passed all the papers of Nursing-I, II, III, and IV, except the said paper i.e. 5420-Community Health Nursing-II of B.Sc. Nursing IV year.
4. Learned counsel further submits that despite the efforts made by him, he could not clear the said paper and if the petitioner is not allowed to appear in the said examination, the entire course undertaken so far will be annulled and will adversely affect his future prospects. Thus, requesting for an opportunity to appear in the upcoming examination of the said paper.
5. The counsel for the petitioner referred to an interim order dated 09.11.2022 passed by the Coordinate Bench at Principal


