Order

1. Learned counsel for the petitioners submits that vide order dated 07.10.2025 of this Court, notices were issued to the

respondents but the aforesaid order has not been complied with yet.

2. Learned counsel for the petitioners further submits that on 09.10.2025, respondents started demolition of the premises of the petitioners without following the procedure laid down by the Hon'ble Supreme Court in the case of **Re Manoj Tibrewal Akash** reported in **2024 SCC OnLine SC 3210** decided on **06.11.2024**.

Learned counsel for the petitioners further submits that no specific notice for demolition has been given to the petitioners and a general notice has been issued on 03.10.2025 by the concerned Gram Panchayat, Khachariyawas, District Sikar, Rajasthan.

3. In that view of the matter, issue notice of the main petition as well as stay application to the respondents by both modes i.e. by ordinary course as well as by registered post, returnable within two weeks.

4. Requisites be filed within a period of one week.

5. List the matter after two weeks.

6. It is made clear that till next date of hearing, the respondents are directed not to demolish the premises of the petitioners.
