Learned counsel for the petitioner submits that in pursuance of the Advertisement dated 07.02.2024 issued by the respondent - Municipal Council, Dausa, the petitioner participated in the E-auction proceeding for Plot No.50 (C-Block), wherein the bid submitted by the petitioner was found to be the highest. However, the Committee has refused to accept the said bid, against which the petitioner approached the Permanent Lok Adalat, Dausa and vide judgment dated 16.09.2025, the Permanent Lok Adalat has ordered the petitioner to deposit the amount in relation to the said plot within a period of fifteen days and further directions were given to the Municipal Council, Dausa to issue the allotment letter in favour of the petitioner.

Learned counsel for the petitioner submits that the said judgment dated 16.09.2025 was passed in the presence of the counsel representing the Municipal Council, Dausa and the same has not been challenged any further. In spite thereof, the Municipal Council, Dausa has issued an Advertisement dated 25.08.2025, wherein again the said Plot No.50 (C-Block) has been put to auction. Learned counsel for the petitioner further submits that the auction proceedings with regard to the said plot have not been finalized till date.
