with all consequential benefits and salary of the intervening period alongwith interest may also be directed to be released in favour of the humble petitioner by the respondents in the interest of justice.

3. The complete record related to such aforementioned noting recorded in the service book may also be directed to be submitted before this Hon'ble Court by the respondents and accordingly all such orders if exists may also be quashed and set aside, in the interest of justice.

4. Appropriate suitable directions for taking disciplinary action against private respondent may also be ordered in the interest of justice.


5. The salary after from May 2024 may also be directed to be released with its arrears and interest @9% p.s. by the respondents and if deemed appropriate the respondent No.1 and 2 may be directed to recover such amount of salary from the private respondent because of his illegal acts the humble petitioner has been deprived of his livelihood and an arbitrary and illegal manner after conducting thorough inquiry in the interest of justice.

2. During course of arguments, learned AAG has placed on record order dated 15.12.2025 passed by the Executive Officer, Municipal Board, Mahuwa, District Dausa and as per order, the termination entry made in service book has been deleted and the petitioner has been reinstated. Learned AAG further submits that the consequences pursuant to the order will be followed.


