1. Learned counsel for the petitioner submits that the Rajasthan
Cricket Association vide order dated 11.10.2025 (Annexure-8),



disaffiliated the District Cricket Association, Jodhpur (hereinafter referred to as "the DCA").

2. Learned counsel for the petitioner further submits that one of the signatories, who passed the impugned order dated 02.11.2025 (Annexure-9), was Mr. Dhananjay Singh who was the President of the DCA. It is contended that since the DCA itself stood disaffiliated on 11.10.2025 (Annexure-8), Mr. Dhananjay Singh could not be considered as a Member of the Ad hoc Committee and consequently, was not competent to participate in the meeting or pass the impugned order dated 02.11.2025.

4. Considering the submissions made above, issue notice. Issue notice of the stay application as well.

5. Meanwhile, the effect and operation of the order dated 02.11.2025 (Annexure-9) shall remain stayed.
