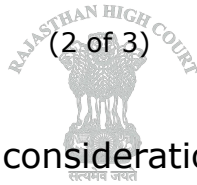

Upon a prima facie consideration of the contents of FIR No.119/2026 dated 28.05.2026 registered under Sections 189(2),223(a),285 of BNS,2023 and Section 8B of the National Highways Act,1956, the material placed on record and the submissions advanced by learned counsel for the petitioner, this Court is of the opinion that the matter raises substantial questions requiring examination in exercise of the inherent jurisdiction of this Court under Section 528 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Prima facie, the allegations reflected in the FIR appear to have emanated from a political assembly and subsequent procession, wherein the petitioner is alleged to have participated along with several other persons. Whether the allegations, even if accepted in their entirety, satisfy the essential ingredients of the offences alleged against the petitioner; whether the necessary foundational facts exist to attribute individual criminal liability to the petitioner; whether the registration of the FIR is supported by legally sustainable material; and whether the continuation of the criminal proceedings would amount to an abuse of the process of law, are issues which warrant judicial scrutiny. Without expressing any opinion on the merits of the rival contentions, this Court is satisfied that the petition discloses arguable grounds necessitating interference at this stage and, therefore, deserves consideration.

2. Notice need not be issued as Mr. Deepak Choudhary, learned AAG, has put in appearance on behalf of the respondents. He seeks time to file reply.
