1. Learned Additional Advocate General submits that affidavits,
of each and every officer; Superintendent of the Nari Niketan/

Balika Grah/ Bal Grah and Foster Home, will be filed providing all the details as to what facilities are presently existing and also those which are required to be placed for the convenience of the inmates.

2. The details relating to installation of CCTV, power backup, medical facilities, water purifier, food equipments, fire systems, clothes, toiletries, etc. as well as details regarding the persons assisting at the places relating to cleanliness like safai karamchari, cook and chowkidar shall also be provided.

3. The Superintendent shall also file the details of the vocational training being provided and the name of concerned person who is being deputed for the said purpose and his or her qualification. The name of the schools where the children/ inmates are sent for regular studies shall also be provided. The details regarding any donation being received individually, in particularly the aforesaid institution, shall also be provided.

4. List these cases again on 11th August, 2026.

5. It is made clear that on account of any immediate requirement of shifting of the children arising, the request shall be forwarded and the State Government shall look into it and make alternative arrangements. The State Government shall also provide information as to the proposed plans of increasing the space area as well as the rooms for comfortable stay of the inmates with the latest facility as well as the addition of washroom for males as well as females in the premises.
